Annex I-Instructions to Offerors

A. Introduction

1. General

Purpose of RFP: for mobilization of community groups, undertake legal literacy; establish police- public interface and Capacity development of Local agencies in the area of local governance to enhance stability in select districts in Herat
for UNDP Afghanistan as per enclosed Terms of Reference (TOR) as Annex III.

2. Cost of proposal

The Offeror shall bear all costs associated with the preparation and submission of the Proposal, the UNDP will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the solicitation.

B. Solicitation Documents

3. Contents of solicitation documents


Proposals must offer services for the total requirement. Proposals offering only part of the requirement will be rejected. The Offeror is expected to examine all corresponding instructions, forms, terms and specifications contained in the Solicitation Documents. Failure to comply with these documents will be at the Offeror's risk and may affect the evaluation of the Proposal.

4. Clarification of solicitation documents

A prospective Offeror requiring any clarification of the Solicitation Documents may notify the procuring UNDP entity in writing at the organization's mailing address or fax number indicated in the RFP. The procuring UNDP entity will respond in writing to any request for clarification of the Solicitation Documents that it receives earlier than two weeks prior to the deadline for the submission of Proposals. Written copies of the organization's response (including an explanation of the query but without identifying the source of inquiry) will be sent to all prospective Offerors that has received the Solicitation Documents.

8. Proposal form

15. Proposal form

The Offeror shall structure the operational and technical part of its Proposal as follows:

(a) Management plan

This section should provide corporate orientation to include the year and state/country of incorporation and a brief description of the Offeror's present activities. It should focus on services related to the Proposal.

This section should also describe the organizational unit(s) that will become responsible for the contract, and the general management approach towards a project of this kind. The Offeror should comment on its experience in similar projects and identify the person(s) representing the Offeror in any future dealing with the procuring UNDP entity.

(b) Resource plan



This should fully explain the Offeror's resources in terms of personnel and facilities necessary for the performance of this requirement. It should describe the Offeror's current capabilities/facilities and any plans for their expansion.

(c) Proposed methodology

This section should demonstrate the Offeror's responsiveness to the specification by identifying the specific components proposed, addressing the requirements, as specified, point by point; providing a detailed description of the essential performance characteristics proposed warranty; and demonstrating how the proposed methodology meets or exceeds the specifications.

22. Deadline for submission of proposals

Proposals must be received by the UNDP at the address specified under clause *Sealing and marking of Proposals* no later than **18 January 2011 on or before 15:00 pm Kabul local time.**

The procuring UNDP entity may, at its own discretion extend this deadline for the submission of Proposals by amending the solicitation documents in accordance with clause *Amendments of Solicitation Documents*, in which case all rights and obligations of the procuring UNDP and Offerors previously subject to the deadline will thereafter be subject to the deadline as extended.

23. Late Proposals

Any Proposal received by the procuring UNDP entity after the deadline for submission of proposals, pursuant to clause *Deadline for the submission of proposals*, will be rejected.

24. Modification and withdrawal of Proposals

The Offeror may withdraw its Proposal after the Proposal's submission, provided that written notice of the withdrawal is received by the procuring UNDP entity prior to the deadline prescribed for submission of Proposals.

The Offeror's withdrawal notice shall be prepared, sealed, marked, and dispatched in accordance with the provisions of clause *Deadline for Submission of Proposals*. The withdrawal notice may also be sent by telex or fax but followed by a signed confirmation copy.

No Proposal may be modified subsequent to the deadline for submission of proposals.


No Proposal may be withdrawn in the Interval between the deadline for submission of proposals and the expiration of the period of proposal validity specified by the Offeror on the Proposal Submission Form.

E. Opening and Evaluation of Proposals

25. Opening of proposals

The procuring entity will open the Proposals in the presence of a Committee formed by the Head of the procuring UNDP entity.

To assist in the examination, evaluation and comparison of Proposals, the Purchaser may at its discretion, ask the Offeror for clarification of its Proposal. The request for clarification and the response shall be in writing and no change in price or substance of the Proposal shall be sought, offered or permitted.

27. Preliminary examination

The Purchaser will examine the Proposals to determine whether they are complete, whether any computational errors have been made, whether the documents have been properly signed, and whether the Proposals are generally in order.

Arithmetical errors will be rectified on the following basis: If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected. If the Offeror does not accept the correction of errors, its Proposal will be rejected. If there is a discrepancy between words and figures the amount in words will prevail.

Prior to the detailed evaluation, the Purchaser will determine the substantial responsiveness of each Proposal to the Request for Proposals (RFP). For purposes of these Clauses, a substantially responsive Proposal is one which conforms to all the terms and conditions of the RFP without material deviations. The Purchaser's determination of a Proposal's responsiveness is based on the contents of the Proposal itself without recourse to extrinsic evidence.


A Proposal determined as not substantially responsive will be rejected by the Purchaser and may not subsequently be made responsive by the Offeror by correction of the non-conformity.

28. Evaluation and comparison of proposals

A two-stage procedure is utilized in evaluating the proposals, with evaluation of the technical proposal being completed prior to any price proposal being opened and compared. The price proposal of the Proposals will be opened only for submissions that passed the minimum technical score of 70% of the obtainable score of 1000 points in the evaluation of the technical proposals.

The technical proposal is evaluated on the basis of its responsiveness to the Term of Reference (TOR).

In the Second Stage, the price proposal of all contractors, who have attained minimum 70% score in the technical evaluation, will be compared. The contractor will be awarded to the Contractor offering the lowest price.

1. LEGAL STATUS

The Contractor shall be considered as having the legal status of an independent contractor vis-à-vis UNDP. The Contractor's personnel and sub-contractors shall not be considered in any respect as being the employees or agents of UNDP or the United Nations.

2. SOURCE OF INSTRUCTIONS

The Contractor shall neither seek nor accept instructions from any authority external to UNDP in connection with the performance of its services under this Contract. The Contractor shall refrain from any action which may adversely affect UNDP or the United Nations and shall fulfill its commitments with the fullest regard to the interests of UNDP.

3. CONTRACTOR'S RESPONSIBILITY FOR EMPLOYEES

The Contractor shall be responsible for the professional and technical competence of its employees and will select, for work under this Contract, reliable individuals who will perform effectively in the implementation of this Contract, respect the local customs, and conform to a high standard of moral and ethical conduct.

4. ASSIGNMENT

The Contractor shall not assign, transfer, pledge or make other disposition of this Contract or any part thereof, or any of the Contractor's rights, claims or obligations under this Contract except with the prior written consent of UNDP.

5. SUB-CONTRACTING

In the event the Contractor requires the services of sub-contractors, the Contractor shall obtain the prior written approval and clearance of UNDP for all sub-contractors. The approval of UNDP of a sub-contractor shall not relieve the Contractor of any of its obligations under this Contract. The terms of any sub-contract shall be subject to and conform with the provisions of this Contract.

6. OFFICIALS NOT TO BENEFIT

The Contractor warrants that no official of UNDP or the United Nations has received or will be offered by the Contractor any direct or indirect benefit arising from this Contract or the award thereof. The Contractor agrees that breach of this provision is a breach of an essential term of this Contract.

7. INDEMNIFICATION

The Contractor shall indemnify, hold and save harmless, and defend, at its own expense, UNDP, its officials, agents, servants and employees from and against all suits, claims, demands, and liability of any nature or kind, including their costs and expenses, arising out of acts or omissions of the Contractor, or the Contractor's employees, officers, agents or sub-contractors, in the performance of this Contract. This provision shall extend, inter alia, to claims and liability in the nature of workmen's compensation, products liability and liability arising out of the use of patented inventions or devices, copyrighted material or other intellectual property by the Contractor, its employees, officers, agents, servants or sub-contractors. The obligations under this Article do not lapse upon termination of this Contract.

8. INSURANCE AND LIABILITIES TO THIRD PARTIES

8.1 The Contractor shall provide and thereafter maintain insurance against all risks in respect of its property and any equipment used for the execution of this Contract.

8.2 The Contractor shall provide and thereafter maintain all appropriate workmen's compensation insurance, or its equivalent, with respect to its employees to cover claims for personal injury or death in connection with this Contract.

8.3 The Contractor shall also provide and thereafter maintain liability insurance in an adequate amount to cover third party claims for death or bodily injury, or loss of or damage to property, arising from or in connection with the provision of services under this Contract or the operation of any vehicles, boats, airplanes or other equipment owned or leased by the Contractor or its agents, servants, employees or sub-contractors performing work or services in connection with this Contract.

8.4 Except for the workmen's compensation insurance, the insurance policies under this Article shall:

(i) Name UNDP as additional insured;

(ii) Include a waiver of subrogation of the Contractor's rights to the insurance carrier against UNDP;

(iii) Provide that UNDP shall receive thirty (30) days written notice from the insurers prior to any cancellation or change of coverage.

8.5 The Contractor shall, upon request, provide UNDP with satisfactory evidence of the insurance required under this Article.

The Contractor shall not cause or permit any lien, attachment or other encumbrance by any person to be placed on file or to remain on file in any public office or on file with UNDP against any monies due or to become due for any work done or materials furnished under this Contract, or by reason of any other claim or demand against the Contractor.



10. TITLE TO EQUIPMENT

Title to any equipment and supplies that may be furnished by UNDP shall rest with UNDP and any such equipment shall be returned to UNDP at the conclusion of this Contract or when no longer needed by the Contractor. Such equipment, when returned to UNDP, shall be in the same condition as when delivered to the Contractor, subject to normal wear and tear. The Contractor shall be liable to compensate UNDP for equipment determined to be damaged or degraded beyond normal wear and tear.

11. COPYRIGHT, PATENTS AND OTHER PROPRIETARY RIGHTS

At the UNDP's request, the Contractor shall take all necessary steps, execute all necessary documents and generally assist in securing such proprietary rights and transferring them to UNDP in compliance with the requirements of the applicable law.

12. USE OF NAME, EMBLEM OR OFFICIAL SEAL OF UNDP OR THE UNITED NATIONS

The Contractor shall not advertise or otherwise make public the fact that it is a Contractor with UNDP, nor shall the Contractor, in any manner whatsoever use the name, emblem or official seal of UNDP or the United Nations, or any abbreviation of the name of UNDP or the United Nations in connection with its business or otherwise.

13. CONFIDENTIAL NATURE OF DOCUMENTS AND INFORMATION

13.1 All maps, drawings, photographs, mosaics, plans, reports, recommendations, estimates, documents and all other data compiled by or received by the Contractor under this Contract shall be the property of UNDP, shall be treated as confidential and shall be delivered only to UNDP authorized officials on completion of work under this Contract.

13.2 The Contractor may not communicate at any time to any other person, Government or authority external to UNDP, any information known to it by reason of its association with UNDP which has not been made public except with the authorization of UNDP; nor shall the Contractor at any time use such information to private advantage. These obligations do not lapse upon termination of this Contract.

14. FORCE MAJEURE; OTHER CHANGES IN CONDITIONS



- 14.1 Force majeure, as used in this Article, means acts of God, war (whether declared or not), invasion, revolution, insurrection, or other acts of a similar nature or force which are beyond the control of the Parties.
- 14.2 In the event of and as soon as possible after the occurrence of any cause constituting force majeure, the Contractor shall give notice and full particulars in writing to UNDP, of such occurrence or change if the Contractor is thereby rendered unable, wholly or in part, to perform its obligations and meet its responsibilities under this Contract. The Contractor shall also notify UNDP of any other changes in conditions or the occurrence of any event which interferes or threatens to interfere with its performance of this Contract. The notice shall include steps proposed by the Contractor to be taken including any reasonable alternative means for performance that is not prevented by force majeure. On receipt of the notice required under this Article, UNDP shall take such action as, in its sole discretion, it considers to be appropriate or necessary in the circumstances, including the granting to the Contractor of a reasonable extension of time in which to perform its obligations under this Contract.
- 14.3 If the Contractor is rendered permanently unable, wholly, or in part, by reason of force majeure to perform its obligations and meet its responsibilities under this Contract, UNDP shall have the right to suspend or terminate this Contract on the same terms and conditions as are provided for in Article 15, "Termination", except that the period of notice shall be seven (7) days instead of thirty (30) days.

15. TERMINATION

- 15.1 Either party may terminate this Contract for cause, in whole or in part, upon thirty days notice, in writing, to the other party. The initiation of arbitral proceedings in accordance with Article 16 "Settlement of Disputes" below shall not be deemed a termination of this Contract.
- 15.2 UNDP reserves the right to terminate without cause this Contract at any time upon 15 days prior written notice to the Contractor, in which case UNDP shall reimburse the Contractor for all reasonable costs incurred by the Contractor prior to receipt of the notice of termination.
- 15.3 In the event of any termination by UNDP under this Article, no payment shall be due from UNDP to the Contractor except for work and services satisfactorily performed in conformity with the express terms of this Contract. The Contractor shall take immediate steps to terminate the work and services in a prompt and orderly manner and to minimize losses and further expenditures.
- 15.4 Should the Contractor be adjudged bankrupt, or be liquidated or become insolvent, or should the Contractor make an assignment for the benefit of its creditors, or should a Receiver be appointed on account of the insolvency of the Contractor, UNDP may, without prejudice to any other right or remedy it may have, terminate this Contract forthwith. The Contractor shall immediately inform UNDP of the occurrence of any of the above events.



16. SETTLEMENT OF DISPUTES

16.1. Amicable Settlement

The Parties shall use their best efforts to settle amicably any dispute, controversy or claim arising out of, or relating to this Contract or the breach, termination or invalidity thereof. Where the parties wish to seek such an amicable settlement through conciliation, the conciliation shall take place in accordance with the UNCITRAL Conciliation Rules then obtaining, or according to such other procedure as may be agreed between the parties.

16.2. Arbitration

Unless, any such dispute, controversy or claim between the Parties arising out of or relating to this Contract or the breach, termination or invalidity thereof is settled amicably under the preceding paragraph of this Article within sixty (60) days after receipt by one Party of the other Party's request for such amicable settlement, such dispute, controversy or claim shall be referred by either Party to arbitration in accordance with the UNCITRAL Arbitration Rules then obtaining, including its provisions on applicable law. The arbitral tribunal shall have no authority to award punitive damages. The Parties shall be bound by any arbitration award rendered as a result of such arbitration as the final adjudication of any such controversy, claim or dispute.

PRIVILEGES AND IMMUNITIES

Nothing in or relating to this Contract shall be deemed a waiver, express or implied, of any of the privileges and immunities of the United Nations, including its subsidiary organs.

TAX EXEMPTION

18.1 Section 7 of the Convention on the Privileges and Immunities of the United Nations provides, inter-alia, that the United Nations, including its subsidiary organs, is exempt from all direct taxes, except charges for public utility services, and is exempt from customs duties and charges of a similar nature in respect of articles imported or exported for its official use. 19.2 Any breach of this representation and warranty shall entitle UNDP to terminate this Contract immediately upon notice to the Contractor, at no cost to UNDP.

MINES

20.1 The Contractor represents and warrants that neither it nor any of its suppliers is actively and directly engaged in patent activities, development, assembly, production, trade or manufacture of mines or in such activities in respect of components primarily utilized in the manufacture of Mines. The term "Mines" means those devices defined in Article 2, Paragraphs 1, 4 and 5 of Protocol II annexed to the Convention on Prohibitions and Restrictions on the Use of Certain Conventional Weapons Which May Be Deemed to Be Excessively Injurious or to Have Indiscriminate Effects of 1980.


20.2 Any breach of this representation and warranty shall entitle UNDP to terminate this Contract immediately upon notice to the Contractor, without any liability for termination charges or any other liability of any kind of UNDP.

OBSERVANCE OF THE LAW

The Contractor shall comply with all laws, ordinances, rules, and regulations bearing upon the performance of its obligations under the terms of this Contract.

Annex III- Terms of Reference (TOR)

Request for proposal (RFP) – for mobilization of community groups, undertake legal literacy; establish police- public interface and Capacity development of Local agencies in the area of local governance to enhance stability in select districts in Heart

A. Introduction

One of the critical areas of work of the UNDP in Afghanistan is in the area of Crisis Prevention and Recovery, within which there are important projects as the [Law and Order Trust Fund for Afghanistan \(LOTFA\)](#), [Counter Narcotics Trust Fund \(CNTF\)](#), [Comprehensive Disaster Risk Reduction Program \(CDRRP\)](#), and [Afghanistan’s New Beginnings Program \(ANBP\)](#). The UNDP is also working in the area of Democratic Policing known as “*police e mardumi*” to undertake institution building of the police especially in the area of improving the relationship between the police and the public. UNDP in other jurisdictions with similar socio political situations has undertaken innovative programmes to bring the law enforcement agencies closer to their people. The program is known by different names in different jurisdictions. In Afghanistan, the UNDP has undertaken a comprehensive study on Prospects of Democratic Policing in Afghanistan based on extensive field based research in select districts of Kabul. This was undertaken based primarily on Ministry of Interior (MOI’s) priorities and the Ministry has shown keen interest to implement the project with the support of the UNDP. Further from 2009 onwards UNDP has made strategic inputs at district level on Pilot basis to build relations between the police and community and thereby improve public confidence in the police.

The role of any police is to establish relations with the public, protect citizens against violence, and work as a component of the criminal justice system. The present work includes continuing to make endeavors to build extensive police and community relations at the cities, towns, and villages with the purpose of enforcing rule of law combined with an elaborate public awareness program of their rights and duties which will reinforce the MoI’s role to build legitimacy. Capacity development and education of the police, public, media, policy makers, civil society are vital components of the project.

Further, Democratic Policing has initiated joint pilot programme with UNDP Afghanistan Sub national Governance and Development project(ASGP) in Herat province to link local governance and development to enhance stability in the province. In this context Democratic Policing will partner with ASGP to implement joint capacity development initiative to improve stability through improved local governance.

Vision and Objectives of Democratic Policing:

To establish systems and mechanisms in place to improve public confidence in the police at the local- level.

- To develop an informal yet acknowledged channel where individual and collective aspirations of community groups can be communicated to the local police and government through a democratic process.
- To develop understanding amongst the rank and file of the police towards the concerns of the community
- To promote systems which will facilitate accountable, effective and responsive policing

Implementers of Democratic Policing

Police e mardumi is jointly implemented by MOI and the UNDP. The implementation process has been undertaken in coordination with bilateral agencies undertaking police reforms initiatives. Ground initiatives and outreach programs with the public and community groups have been undertaken with the newly emerging Afghanistan civil society organizations.

Project components

1. Project Facilitation:

All project activities have been coordinated by a small project team with MoI.

2. Establish Community Groups and dialogue platforms.

Community level groups have been established in Pilot districts to communicate with the local police/beat officer on a regular basis on policing issues and have undertaken the preparation of crime and security plans for the district. The meetings between the community and the police are recorded and action taken or follow up is also undertaken.

3. Community Level Facilitators:

Civil Society Groups have been facilitating the community-police meetings, document and also capacity build the community members, leaders and para legals etc. Legal education and communication skills training is undertaken for the police.

4. Capacity Development:

The Police e mardumi efforts have a large capacity development strategy for its various stakeholders. The capacity building is undertaken through workshops, trainings using participatory learning: Police Peer Educators, CSO's, Lawyers, Para Legals, Parliamentarians, Media and Community Security Groups etc. Also a broadcast programme over radio has been undertaken informing people about their rights and responsibilities.

5. Initiatives at the Police Stations:

- Information desks established.
- A standard documentation process is being explored for all complaints brought in by the public to the police station.



6. Civilian and civil society oversight mechanism

Two types of civil society oversight mechanisms are currently being explored. Civil Society groups and other informed groups such as Parliamentarians, civil society etc are being informed on police reforms processes in an effort to build up a critical mass which can push for overall reforms in the police. Further a public complaints mechanism such as the 119 which is currently functioning as a hotline at the MOI needs to be expanded. *Police e mardumi* feels establishing such systems will support in building the bridge between the police and public and make the police accountable.


B. Request for proposal (RFP) – for mobilization of community groups, undertake legal literacy; establish police- public interface and Capacity development of Local agencies in the area of local governance to enhance stability in select districts in Herat

- For mobilization of community groups, undertake legal literacy and establish police- public interface across province of Herat (4 districts) and undertake a women’s platform to discuss human security and crime on quarterly basis.
- Train local officials, DDA members, local leaders in the area of good local governance, stability, development facilitation and service delivery accountability further establish provincial level civil society and local authority network/platform for facilitating effective local governance and stability in the Herat province.

Introduction

Ordinary people especially those living in rural/semi-rural areas are mostly ignorant about the laws and Constitution of the country that protects them while they interface with the law enforcement agencies especially the police at the local level. Therefore this activity proposes mobilization of community groups, undertake legal literacy and establish police- public interface in select districts in Herat. Similar activities are in the process of being implemented in Nangarhar and Kabul. Between September 2009 to October 2010 MOI-UNDP in partnership with civil society groups has successfully undertaken local community mobilization, provided legal literacy to the community groups including maliks, wakils, District Development Assembly members, local governance council members, youth and women. Representatives of the community, local governance council members and the police together have met at a forum on a bi monthly basis to resolve local issues. Further together these groups established a channel of commitments by preparing a crime and security plan for the area which helps in defining roles and responsibilities of each of the members.

Through trainings on laws, legislations and government policies the local community members were capacitated so that they could pro-actively engage with the police and other government institutions. Further those members of the community who showed interest we provided additional legal knowledge so that they can support some of the needs of the community. These groups of village facilitators were found to be important dissemination channels at the local level. This component of training, networking and discussion forums are found to be sustainable processes while maintaining security in an area.

Therefore taking into consideration this positive interface at Pilot districts in Kabul, UNDP would like to expand this process to new areas and continue its engagement with the local groups in the Pilot areas over the next 12 months.

Objectives:

- To mobilize community groups, community leaders and police effectively so that they may contribute information to maintain community security.
- To initiate a positive interface between police and public through an informed process.
- To educate the community groups/leaders of their rights while they interface with the law enforcement especially the police.
- To establish a network of village facilitators who will have adequate knowledge to support the requirements of the community when a local or security issue may arise at the local level.
- To document and establish a women’s forum to discuss human security and crime which impact women.
- To train Herat local officials, community leaders, DDAs and establish civil society and local authority network on local governance and stability in the Herat province.

Outputs:

- Quick needs assessment report of the district based on existence of community groups, types, their perceptions of the police and the difficulties faced by the police undertaken etc. This report maybe used to measure successes or failures of the project during end term evaluation.
- Bi Monthly interface undertaken with local police, sub-governor, community leader/community groups at local level for 12 months which will produce a crime and security plan which will clearly define roles and responsibilities of the stakeholders at the local level.
- 12 days legal literacy meetings with community groups/leaders at local level.
- Establish criteria for identifying village facilitators who will receive the 12 days of legal literacy (as mentioned above) plus 8 full days legal literacy classes
